- Trade mark devices (if applicable) and design representations are shown in renewal reminder notices to help you identify cases easily

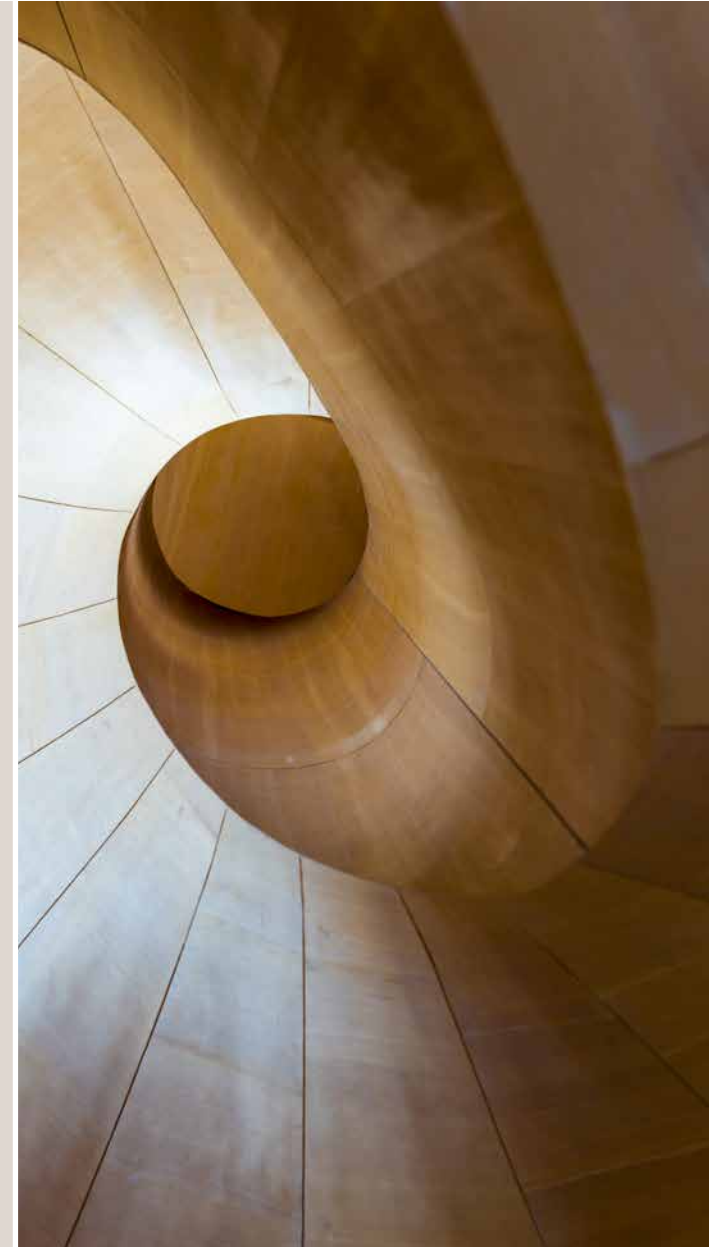


European Validation Service
